It has been another incredibly exciting and successful year for the Colorado Public Health Association (CPHA). We kicked-off the year after the largest Public Health in the Rockies Conference yet with over 700 attendees from across the region, a record number of sponsors and exhibitors, and nearly 200 sessions boasting all of the current and innovative work happening across Colorado!

Shortly after the conference, CPHA elected its first Health Equity Director, Jason Vitello, who supported the development of a thriving interdisciplinary Health Equity Coalition comprised of remarkable individuals from various sectors of the community. This coalition has put in immense thought into its internal structure and focus areas as well as the recommendations it has provided to help guide CPHA grow with its health equity work. The impacts of these efforts have already been demonstrated through the increased intentionality in integrating equity promoting strategies in our policy, student engagement, and professional education efforts to truly bring to life CPHA's health equity vision: that all Coloradans have the opportunities essential to attaining their highest level of health.

2018 has already been a busy year that started with an active legislative session, during which CPHA took a position on 16 bill. The two which CPHA activity lobbied for (opioid misuse prevention and expanding access to behavioral health care providers) as well as seven others were signed by the Governor. Other highlights from this year include:

Successfully leading the Culture of Data conference for the second year

- Partnering with a variety of organizations such as the Colorado School of Public Health, Rocky Mountain Public Health Training Center,
  The Colorado Health Foundation, Trailhead Institute, Colorado Association of Local Public Health Officials, Colorado Health Institute,
  and the Public Health Nurses Association of Colorado on a variety of National Public Health Week activities, including the largest Public
  Health Day at the Capitol
- Transitioning all of our board and committee meetings to Zoom to be more inclusive of people who may experience barriers to attending in-person meetings

• Strong and stable financials (though as a small non-profit, donations are always welcome!)

- Hosting five health equity webinars ranging in topics from powerful storytelling and gathering community voices to rural inequities uncovered through the Colorado Health Access Survey and tools to advancing health equity
- Engaging students through a health equity panel and dialogues around what health equity means for students
- Offering mentorship to 38 students and professionals through the Colorado Public Health Mentoring Program
- Providing leadership training to nine students through our Explore Public Health pipeline program

• Reaching an all-time high for our membership with over 730 members

• Tremendous growth in our social media presence with over 300 followers on Twitter, over 500 followers on Instagram (which we just started this year), and over 950 followers on Facebook!

In short, CPHA is thriving! Thanks to our passionate board of directors, dedicated committee members, collaborative partners, generous donors and sponsors, and engaged community, CPHA has been able to serve as a strong pillar in the Colorado public health community. I am grateful for this opportunity to have worked alongside so many gracious contributors committed to improving the health of all Coloradans and look forward to continued partnerships as we continue striving to more effectively and equitably serve the full state. #### CPHA 2017-2018 Policy Actions via Urgent Protocol

On November 16, 2017, the CPHA Board enacted its urgent protocol to sign on to the APHA's letter to Senate leaders of the Finance Committee and the Health, Education, Labor and Pensions Committee supporting reauthorization of CHIP and other safety net health program, but opposing efforts to cut and use the Prevention and Public Health Fund as an offset to pay for the legislation

On December 19, 2017, the CPHA Board enacted its urgent protocol to sign on to the APHA's letter to Acting Secretary Hargan of Department of Health and Human Services to communicate the concerns about the information regards to the CDC budget analysis were discouraged from using seven words that are important to public health when preparing the President's Fiscal Year 2019 budget and asking for clarification about the information.

On February 28, 2018, the CPHA Board enacted its urgent protocol to sign on to the 2017 iDrive white paper as CPHA currently supports SB18-108 - making it easier for undocumented immigrants to get drivers' licenses.

On April 23, 2018, the CPHA Board enacted its urgent protocol to sign on to the letter to Representative Diana Degette to thank her for her work defending the FDA and fighting the tobacco lobby.



### Treasurer: Katie Gelman

The role of the CPHA Treasurer is to support the financial management of the organization by providing budgetary support across committees, providing oversight and review of monthly financial statements, approving expense and reimbursement requests, and supporting long term planning for the financial health of the organization. In 2018, several key successes were accomplished related to infrastructure development and streamlining of finance related processes and protocols. These activities included:

- Launch of the finance subcommittee and facilitation and documentation of committee goals and objectives, including short term infrastructure improvements, and long term planning for financial diversification and organizational support.
- Implementation of a full organizational audit, and identification of process improvements based on audit results.
- Development and implementation of updated and standardized budgeting, expense, and reimbursement forms for board member and committee utilization.
- Development and implementation of a CPHA finance and expense policy to guide board member and committee decisions around budgeting and expenses.

In the coming months, the finance subcommittee will be working to identify long term financial goals that align with CPHA's strategic plan and priority areas. We are also looking to expand our newly formed committee to gain broader and more diverse perspectives and backgrounds to support identification and implementation of financial goals- we'd love to have you join our team!

Below, we provide the 2017 financial data, comparing budget to actual income and expenses. We finished the 2017 year with a net profit of \$39,886.

In general, the state of CPHA membership growth has been steady and strong over the last five years. Since 2013, CPHA's membership has grown 187% from 363 members in September of 2013 to 680. 2018 has been a time of transition for the Membership Committee. Our CPHA Membership Director resigned this Spring due to competing priorities, and the Board has worked to connect membership activities to several of CPHA's robust opportunities occurring in various areas of the association. Just to highlight a few ways membership has engaged with CPHA, CPHA's Health Equity Coalition has taken over the responsibility of coordinating and hosting Monthly Health Equity Webinars, the Culture of Data Conference has grown so large it has now become a committee of its own, and National Public Health Week engaged membership on a whole new level that CPHA is excited to continue in years to come!

The growth of our Student Membership has been the greatest success in membership this year with a 170% increase over 2017 student membership! Our Student Committee has done a phenomenal job of engaging public health student on multiple campuses and connecting students to actively participate in CPHA areas of interest.



### **Colorado Public Health Mentoring Program (CPHMP)**

CPHMP's vision is "To contribute to an engaged, connected and competent workforce that effectively prevents, promotes and protects the health of Coloradans". CPHMP is guided and administered by a Steering Committee representing CPHA's partnering organizations:


- Colorado School of Public Health

The 2018 CPHMP program experienced unprecedented demands for mentee applicants to be paired with a mentor this year. In fact, we had to turn away nearly as many applicants as we could match. The 2018 CPHMP cohort includes 38 matches this year and represents the diversity of public health practice in Colorado. In January, mentor-mentee matches were announced and introduced. The CPHMP Steering Committee hosted a live Mentor Training webinar on January 19, 2018, with 56% mentor participation, and the CPHMP 2018 Kickoff Training and StrengthsFinder Workshop for all participants on January 26, 2018, with 90% cohort participation. We continue to need quality, passionate and committed mentors to volunteer their time to make this program a success, so please consider joining the CPHMP mentor team in 2019!

## Communications Report

The goal of the CPHA Communications Workgroup in the past two terms has been to increase CPHA's visibility with its internal and external audiences, and promote networking, awareness, and dialogue among members. Improvement on these points were the focus of increasing the individual value of CPHA membership which was to be measured by social media participation and total membership. To do this, the Communications Director worked closely with the other CPHA Directors to increase the volume and diversity of communications, and the CPHA Communications Committee focus on streamlining social media content and organizing communications channels. Additionally, the Committee played a pivotal role in communicating action alerts and increasing awareness of impactful policy changes on the national stage. As a result of these efforts over the past year, CPHA and the Communications team have.

- CPHA has increased our outreach via action alerts and PhotoVoice challenges to engage members as current events take place, including alerts during the Colorado legislative session and Photo Voice Challenge during National Public Health Week.
- In the past year, CPHA's Facebook likes and participation have gone up, Twitter followers are up 20% (34 Tweets with 15k impressions in the 7 months of 2018), Instagram following is up 567% (70 posts in 7 months of 2018), and a new LinkedIn organizational page has been created in 2018 with 69 current followers and currently averaging 10 post per week.

   Membership work agenda started two years ago.

The charter will serve as a foundation and guide us in our mission to: Advance health equity and justice in Colorado through education, leadership development, advocacy, policy change, community engagement, coordinated efforts, and innovative cross sector solutions.

Other significant health equity milestones have been achieved in 2018 and remain underway including:

- An ongoing health equity webinar series

### Public Health in the Rockies 2018 Better Together: Past, Present, Future

The main objective of CPHA's professional education committee is planning and executing the annual Public Health in the Rockies (PHiR) Conference each year and other professional education opportunities for our membership. This year's conference was designed with a focus on celebrating how far public health in Colorado has come from and it's trajectory into the future. This theme was also chosen in collaboration with celebrating the Colorado School of Public Health as our presenting sponsor and their 10-year anniversary.

Attendees may notice the conference format to have a more streamlined schedule and session selections in response to previous post-conference survey feedback. Affiliate partners and planning committee members worked diligently to translate the trajectory and growth of this conference to a new location while ensuring the highest quality of content and maximizing opportunities for engaging, networking, learning, and exploring Copper.

- More than 550 participants registered our biggest conference ever!
- 9 students and early career professionals received scholarships to PHiR
   2018 thanks to generous sponsors and 2017 silent auction proceeds
- 45 sponsors and exhibitors supported this conference
- 130 showcase, skills-building, and poster sessions on a range of relevant public health topics\*

We were thrilled to have confirmed Dr. Nita Mosby Tyler of The Equity Project to be our Keynote Speaker! The APHA President also joined the conference to speak about national level public health.

### **Culture of Data 2018**

This year, CPHA was proud to present the 2nd annual Culture of Data (CoD) on April 6, 2018 at the Arvada Center for the Arts and Humanities. The purpose of this conference is to connect community with data, particularly the underserved, communities of color, and other marginalized groups who disproportionately face inequities. The CoD Planning Committee was proud to secure Natalie Burke as the Keynote speaker. Ms. Burke is a nationally-known speaker, "equity evangelist," strategist, master facilitator, and public health leader, Natalie S. Burke provides executive leadership for CommonHealth ACTION whose mission is to develop people and organizations to produce health through equitable policies, programs, and practices. In addition to the keynote, there were 10 other speakers presenting on various topics related to this year's theme.

- Developed structures and processes to align with the Public Health in the Rockies conference
- Over 258 attendees and 10 sponsors/exhibitors joined us at the conference
- Incredible planning committee with many members who have planned the conference since 2002! The conference was moved from June to April to coincide with Public Health Week. As a result, the planning committee only had 4 months to plan for the CoD..
- Generated \$11,813.13 in profit to be rolled into the CoD budget for next year

### Public Health Policy Report

### Public Health Policy Director: Alison Harvey

### **Policy Update / Overview**

In 2017, nine policy priorities were identified in a CPHA general membership survey:

Eliminate health disparities.

Environmental issues of air, water, and climate change. Expand substance abuse prevention and treatment services. Improve access to comprehensive healthcare.

Increase access to mental health services and integrated care.

Support affordable housing. Support gun violence prevention research. Support healthy eating and active living. Support infectious disease prevention and vaccination.

The 2018 CPHA Public Health Policy Committee decided that further prioritization was needed to develop a strategic, effective legislative agenda. A survey was sent to the CPHA Policy Committee, the CPHA Health Equity Committee, and the CPHA Board, resulting in the CPHA 2018 legislative priorities:

- Support access to comprehensive healthcare.
- Behavioral Health: Increase access to prevention, treatment, and integrated care for mental disorders and substance use disorders.
- Eliminate health disparities, with a particular focus on supporting affordable housing.
